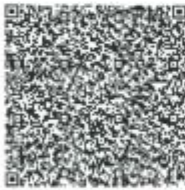

6. That, no part of income from the schools being run by the BSF Education Fund Society Institution is diverted to any member of the society or to any other person. The saving, if any after meeting the recurring and non recurring expenditure and contribution to developmental, depreciation and contingency fund are utilized for promoting the schools of the BSF Education Fund Society and are audited and certified by a Chartered Accountant and proper accounts statements are prepared as per rules.
