
Sub: Recognition Certificate for the School under sub-rule(4) of rule 11 of Right of Children to Free and Compulsory Education Rules, 2009 for the purpose of Section 18 of Right of Children to Free and Compulsory Education Act, 2009.

Dear Sir/Madam,

With reference to your application dated 25.04.2023 and subsequent correspondence with the school/ inspection in this regard, I convey the grant for provisional recognition to the BSF Senior Secondary School, Umpling, East Khasi Hills District, for Class VI(Six) to Class VIII(Eight) for a period of 3 (three) years w.e.f. 5<sup>th</sup> May, 2023 to 4<sup>th</sup> May, 2026.

The above sanction is subject to fulfillment of following conditions: -

1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.
2. The School shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009 (Annexure I) and the Right of Children to Free and Compulsory Education Rules, 2009 (Annexure II).
3. The School shall admit in Class I, to the extent of 25% of the strength of that class, children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary till its completion. Provided further that in case of pre-primary classes also, this norm shall be followed.
4. For the children referred to in paragraph 3, the School shall be reimbursed as per section 12 (2) of the ACT. To receive such reimbursements school shall provide a separate bank account.
5. The Society/School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
6. The School shall not deny admission to any child for lack of age proof if such admission is sought subsequent to the extended period prescribed for admission on the ground of religion, caste or race, place of birth or any of them.
7. The School shall ensure:
  - (i) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
  - (ii) No child shall be subjected to physical punishment or mental harassment.
  - (iii) No child is required to pass any board examination till the completion of elementary education;
  - (iv) Every child completing elementary education shall be awarded a certificate as laid down under Rule 23.
  - (v) Inclusion of Students with disabilities/special needs as per provisions of the Act.
  - (vi) The teachers are required with minimum qualifications as laid under section 23 (1) of the Act. Provided further that the current teachers who, at the commencement of this Act so not possess minimum qualifications shall acquire such qualifications within a period of 5 years.
  - (vii) The teacher performs its duties specified under section 24(1) of the Act and
  - (viii) The teacher shall not engage himself or herself for private teaching activities.
8. The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
9. The School shall enroll students proportionate to the facilities available in the school as per prescribed in the Section 19 of the Act.



12. The School buildings or other structures or the ground are used only for the purposes education and skill development.
13. The School is run by a society registered under the Societies Registration Act, 1860 (21 of 1860), or a public trust constituted under any law for the time being in force.
14. The School is not run for profit to any individual, group or association of individuals or any other persons.
15. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared as per rules. A copy of each of the Statements of Accounts should be sent to the District School Education Officer (Inspector of School) or Sub-Divisional School Education Officer (Deputy Inspector of Schools) every year.
16. The recognition Code Number allotted to your schools is 17060206519. This may please be noted and quoted for any correspondence with this office.
17. The school furnishes such reports and information as may be required by the Director of the School Education & Literacy/ District School Education Officer from time to time and complies with such instructions of the appropriate authority or the District School Education Officer as may be issued secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working of the school.
18. Renewal of Registration of Society if any, be ensured.
19. Other conditions as per the Meghalaya Right of Children to Free and Compulsory Education Rules, 2011 enclosed.




